Agricultural Fees Regulation (Amendment) Order No. 75 of 2013

In exercise of the powers conferred on me by section 1 of the Agricultural Fees Act [CAP 74], I, the Honourable DAVID TOSUL Minister of Agriculture, Livestock, Forestry, Fisheries and Biosecurity, by order make this Regulation.
