

 - Vanuatu society values respects for the freedom and dignity of the individual, freedom of religion, commitment to the rule of law, parliamentary democracy, equality of men and women and a spirit of egalitarianism that embraces mutual respect, tolerance, fair play and compassion for those in need, and the pursuit of the public good
 - Vanuatu society values equality of opportunity for individuals, regardless of their race, religion or ethnic background
 - The English, French and Bislama languages, as the national languages, are important unifying element of Vanuatu society.
